d. Dave Fass reported on his meeting with Mark Eisle – the conex (storage trailer) will be painted to match the berms, mowing and trimming of the parking area completed, blackpowder trailer is to be moved, the gate must be manned to allow non-range members in for club events, Mark is to meet with his employee about moving the club's truck and trailer without permission, Mark will also meet with his employee about the steel and wood that were dumped in the clubs shooting area, Mark will look into moving the concrete table legs at the long range pavilion, pavillion schedule will be coordinated with club, porta potty will be delivered when available, Mark will provide telephone poles for reinforcing the Social Club prop.

e. John Manley gave Dave Faas memorandums recommending a no confidence vote be held at the next meeting to remove Chris Hardy, Rom Reedy, Craig Robbins, Rick Ginter, and Gary Hebert from the Executive Board. Dave will make appropriate notifications.
